- **I understand that:**
- Registration will be based upon prior school conduct, academic record, attendance record, and other pertinent factors.
- The registration fee is **NON-REFUNDABLE**.
- Tuition accounts must be kept current since Bethany School operates strictly on the basis of tuition and fees.
- Annual Tuition is divided into 10 payment periods. **The first payment is due on August 1<sup>st</sup>**. Subsequent payments are due on the 1<sup>st</sup> of each month, through May. *Fill out the credit card charge payment form and return.*
- **A late charge of \$45** will be assessed if payment is not received by the 7<sup>th</sup> of the month (or noon the last day school is in session prior to the 7<sup>th</sup>).
- Student attendance privileges will be affected by delinquent accounts, *which the Principal reviews monthly*; Final report cards or student records will not be released until all outstanding bills are paid..
- The administration has full discretion in the discipline of my child in accordance with school policy.
- The administration has full authority for class placement.
- **Students entering Kindergarten must be 5 years old by September 1<sup>st</sup>.**
- **According to law, all students must provide a record of up-to-date immunizations.**
- I authorize Bethany School to give consent to any necessary medical treatment for my child, in case of an emergency when I cannot be reached. Per your signed Medical Treatment Consent and Liability Release Form.
- I agree to support the school's policies and statement of faith as outlined in the Student Handbook, including the Code of Conduct and the Expected Technology Practices. ## 2020-2021 Bethany School Distance Learning Tuition & Fees

### Annual Registration Fee (NON-REFUNDABLE)

**\$395**

The annual registration fee covers the cost of Association of Christian Schools International (ACSI) student membership, standardized testing, curriculum, yearbook and office costs. This fee is due with the application and guarantees the students a spot in a classroom, to be determined by the administrator. **THIS FEE IS NON-REFUNDABLE.**

### Activity Fee (Will be billed when returning to campus)

**\$85**

The activity fee covers the cost of field trips and bus transportation for class activities and is due prior to the first day of school. This fee will be billed to your first statement.

### Technology Fee

**\$200**

The technology fee covers the cost of maintaining and updating our technology for distance learning.

### Tuition

Tuition payments are monthly installments from August through May, due the first of every month. However, if you choose to pay the **entire tuition** in **one** installment by **August 1<sup>st</sup>**, you will receive an 8% discount for a cash or check. Entire payment made with a credit/debit cards with a Visa or MasterCard logo will receive a 4% discount only (due to processing fees). Split payment fees are \$25.00 per person on the account paying for each month.

### Late Charges

**Tuition is due on the first of each month starting in August ending in May.** Accounts that are not paid completely by noon on the 7<sup>th</sup> (or noon the last day school is in session prior to the 7<sup>th</sup>) will be assessed a late charge of **\$45**. *Student attendance privileges will be affected by delinquent accounts, which the Principal reviews monthly; Final report cards or student records will not be released until all outstanding bills are paid.*
