LONG BEACH SCHOOL REOPENING REQUIREMENTS LONG BEACH HEALTH & HUMAN SERVICES

I. Reporting COVID-19

Bethany School will report if someone tests positive for COVID-19.

- 1 to 2 cases: The Long Beach Department of Health and Human Services will be contacted
- 3 or more cases within 14 days (a cluster): The Long Beach Department of Health & Human Services will be contacted.

II. Reporting COVID-19 Exposure

Bethany School will report if someone is exposed to COVID-19 to the Health Department by completing the Long Beach COVID-19 Case and Contact Line List for the Educational Sector and emailing it to COVID19Edu@longbeach.gov.

III. Weekly Exposure Form

Bethany will submit a Weekly Exposure Form to the Long Beach Department of Health & Human Services updating them of any positive cases, any exposures, any hospitalizations, or deaths on campus due to COVID-19. These forms will be submitted electronically weekly.

IV. Contact Training Tracer Course

All Bethany staff and employees have completed the Contact Training Tracer Course as required by the Long Beach Department of Health & Human Services.

V. Flu Vaccine

All Bethany School staff and employees receive the flu vaccination annually. Staff, students and parents will be educated on the importance of being vaccinated via MySchoolWorx, Dojo and email.

Bethany School will file documentation of completed vaccination of students and staff unless there is a medical exemption for the flu. Medical exemptions will be filed and kept on campus.

By having staff and students vaccinated, Bethany School will be able to help in the following ways;

- Protect the school community from influenza, co-infection with influenza and COVID-19 viruses
- Reduce demands on health care facilities
- Decrease illnesses that cannot be readily distinguished from COVID-19 and would therefore trigger extensive measures from the school and public health authorities

VI. Attestations

- Bethany School has obtained appropriate and sufficient personal protective equipment (PPE) as defined by the reopening protocols and California Department of Public health guidance for all teachers and staff who will be involved in in-person instruction.
- Testing resources have been made available for all Bethany teachers/staff for COVID-19. Teachers/Staff will be tested periodically for COVID-19 by the Long Beach City College Testing site, CVS Pharmacy, teacher/staff's personal primary physician, and or any other means. Teachers will be screened daily when arriving to work and all test results along with daily health checks will be submitted to the principal, Mrs. Tonia Hill.
- Parents will be regularly encouraged to get the flu vaccination for their children. The goal is for all students and staff to be vaccinated unless contraindicated by documented medical exemption for the flu vaccine. The vaccine will help in the following ways;
